- SANCTION:** This meet is sanctioned by USA Swimming and Indiana Swimming. Sanction #IN10285.
- HOST:** Brownsburg Swim Club (BBSC), PO Box 971, Brownsburg, IN 46112
- LOCATION:** Bulldog Aquatic Center *Map below.*

- FACILITY:** The Bulldog Aquatic Center is an 8 lane 50 meter pool. The pool is equipped with non-turbulent lane dividers, Omega touchpads and a Daktronics electronic timing system. Balcony seating is available for more than 900 spectators. The facility has not been certified in accordance with 104.2.2C(4). The water depth at the start end is 6' and at the turn end is 13'.
- RULES:** Current USA Swimming and Indiana Swimming rules will govern this meet. Please pay special attention to USA Swimming Rules; 202.3.2: *At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.*
- ELIGIBILITY:** Swimmer(s) must be registered with USA Swimming to be accepted in this meet. Age as of June 11, 2010, shall determine swimmer's age for the entire meet. Coaches **MUST** constantly display their current USA Swimming coach credential to gain deck access. The meet referee reserves to deny deck access if coach does not comply or card is no longer valid/current. All coaches must sign the Sign-In form at Admission Table each day they are present.
- FORMAT:** All events are **TIMED FINALS**. The 800 Freestyle will be swum as an Open Event and **will not** count toward High Point awards. Athletes in the 800 Freestyle will need to provide a Timer. If they want a lap counter, they will need to provide this also.
- ENTRIES & LIMITATIONS:** Each swimmer will be limited to four (4) events per session. After scratches, if too many events are entered, entries will be accepted in numerical order. There will be **NO** refunds. All entries must be submitted in **LONG COURSE METERS**. "No Time" entries will be accepted.
The Brownsburg Swim Club reserves the right to limit the number of heats in any or all events to keep the time line manageable. Entry fees for events limited by the host will be refunded. Friday evening events will be limited to permit completion of the session between 8:30 and 9:00 p.m
- ENTRY FEE:** Individual Events: \$4.00 per event
Indiana Swimming Surcharge: \$1.50 per swimmer.
- CHECK-IN:** There will be a positive check-in. All swimmers must be signed in **45 minutes** prior to the start of each session.
- DECK ENTRIES:** If the meet is not full, deck entries will be accepted. Deck entries must be received 45 minutes prior to the start of a session. **NEW** swimmers must provide a USA Swimming ID#. The fee for deck entries is \$8 per event, payable immediately.

DEADLINE: Entries will be accepted starting at 8:00 a.m. on May 12, 2010. Entry deadline will be May 26, 2010. We will extend the deadline if the meet is not full.
Time updates will be accepted through June 4, 2010

ENTRY FORMAT: The meet will be run using Hytek’s Windows Meet Manager. Entries must be made by e-mail in the form of an Entry File (entries@brownsburgswimclub.com). For teams with less than 3 swimmers, a list of athletes, their USA Registration numbers, and their events/times will be accepted.
For entries received by e-mail, BBSC will send an acknowledgement that your entry file has been received within 24 hours of submission. Should you not receive an acknowledgement of entry within 24 hours, please contact the entry chair by telephone or email immediately.
For entries received by e-mail, a hard copy of the entries, the Team Registration Form and Summary of Events, Release and Hold Harmless agreement, and a check for entry fees must be received prior to the start of warm-ups on the first day of the meet.

OFFICIALS: The Brownsburg Swim Club will need the help of your USA Swimming Officials. If you have a club officials chairperson, please provide his/her name on the entry summary. All officials must sign the Sign In sheet at the Admissions Table every day they are on deck.

CONCESSIONS: Concessions will be available at the first floor concession stand.

ADMISSION: Admission of \$5 per day will be charged. Children 10 and Under are free.

FACILITY NOTES: The Bulldog Aquatic Center is a state of the art facility. It is important that all people attending the meet, swimmers, coaches, or spectators, treat this facility with the utmost care. Anyone caught abusing the facility will immediately be asked to leave the facility.

The following rules will be strictly enforced:

1. The Brownsburg Community Schools are designated as smoke free zones. Smoking is not permitted anywhere in the facility or outside of the facility on school grounds.
2. No food or drinks with exception of plastic water bottles will be permitted on deck.
3. Due to USA Swimming Insurance requirements **only** swimmers, coaches, officials and volunteers are allowed on deck. **There are no exceptions.**
4. The elevator to the Spectator Seating is for Handicapped people only.

Anyone caught abusing the facility will be asked to leave IMMEDIATELY. Teams will be billed for any damages caused by their swimmers.

USA Swimming Suit Regulations:

In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

Two-Suit Interpretation:

For purposes of Article 102.9 of the USA Swimming Rules & Regulations, Swimwear, the use of more than one swimsuit at a time during any USA Swimming sanctioned or approved competition is prohibited.

Armband/Legband Interpretation:

Article 102.9.1A is not a “jewelry” rule and does not apply to such things as watches, bracelets or hair bands. It is intended to apply to tight elastic or taped bands that some athletes wear around their arms or legs. Loose fitting jewelry and watches (as long as it is not a pacing device) are allowable. Bandages are okay if needed for medical reasons such as for a cut as long as the bandage is not performance enhancing.
