- Facility:** 6 lane, 25 yard pool, Colorado Timing System. Non-smoking campus.
- Concessions:** Concessions will be available all day.
- Heat Sheets:** Heat sheets will be sold throughout the day. This is a pre-seeded meet - no shows will be swimming with an open lane.
- Rules:** Current USA Swimming and Indiana Swimming rules will govern this meet. Please pay special attention to USA Swimming Rules; 202.3.2: At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision. Coaches must constantly display their USA Swimming coaching credential to gain deck access. The meet referee reserves the right to ask for coaching credential display and/or deny deck access if coach does not comply or card is no longer valid/current.
- Eligibility:** All swimmers must be registered with USA Swimming to be accepted into the meet. Age of the swimmer as of November 21, 2009 shall determine the swimmer's age for the meet.
- Suit regulation:** In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in USA Swimming Rule 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.
- Entry Limit:** **Each swimmer will be limited to (5) individual events and (2) relays.**
- Fees:** All fees will be due before the start of the meet.
